CT Drivers' License to Show Veteran Status

Governor Dannel P. Malloy and Lieutenant Governor Nancy Wyman recently announced that military veterans can now apply to have their status marked on a Connecticut Driver's License or state-issued ID. The Department of Motor Vehicles and AAA offices on January 2, 2013 will begin issuing drivers' licenses and ID cards that will include the symbol of an American Flag to identify veteran status.

The veteran identifier on the CT driver's license or state-issued ID card will help first responders, emergency rooms and healthcare providers to identify veterans that are eligible for programs and services from both the Department of Veterans' Affairs and the VA.

At least 30 days prior to visiting a DMV or AAA office, veterans must submit to the state Department of Veterans' Affairs

a completed application and proof of honorable discharge, such as a DD-214. The Department of Veterans Affairs will verify the veteran's military status and electronically notify DMV of the request prior to the driver's license or ID card being issued.

The application can be downloaded online at the Department of Veterans' Affairs website by visiting www.ct.gov/ctva and clicking the "Application for Veteran's Flag" link. The flag symbol will be added to veteran's license or ID card at no additional cost at renewal time or when it is first issued. Veterans can request a flag symbol by mailing an application and additional documentation to the state Department of Veterans' Affairs at: CT DEPARTMENT OF VETERANS' AFFAIRS, ATTN: VETERAN'S FLAG ON DRIVER LICENSE OR ID CARD, 287 WEST ST., ROCKY HILL, CT 06067.

This summer I was fortunate to have two awesome opportunities. The first was three weeks aboard a US Navy Destroyer. I spent three weeks in San Diego, California living and working aboard the USS Gridley. While aboard the USS Gridley I was shadowing a Petty Officer Second Class and learning all I could about enlisted life aboard a Navy ship.

In addition, I gained invaluable information about the opportunities in the Navy through talking with the officers and other enlisted on board. I got to drive the ship, learned how to plot our course on the navigation charts, and spent countless hours on the bridge just watching operations. The second great opportunity I had was to learn how to sail on a 44-ft offshore sail boat. Randomly assigned to a crew of seven midshipmen and a skipper and XO of them only one I had met before we

a crew of seven midshipmen and a skipper and XO, of them only one I had met before, we quickly got to know each other by spending an immense amount of time together learning how to sail. We spent a week learning about the boats and sail theory in a classroom setting. The next week was spent out on the boats sailing around in the Annapolis Harbor area. Once tested, we spent a week sailing up to Rockport, MA where we were warmly received by the town and were met with a host of activities for our 'fleet' of sailors. We then spent a week sailing back to the Naval Academy. I learned not only a lot about sailing, but also about small unit leadership and teamwork, and performance under stress. Trying to change a sail at three in the morning with water crashing over the bow of the boat teaches a lot more than sail theory!

Chapter News

LT Roger Wanamaker, USNR (Ret) was recently appointed to our Executive Board as V. P. Newsletter. Here is his bio:



One spring day in 1960 a gray station wagon with "Fly Navy" on the side drove onto the Colgate University campus. I was finishing my senior year as a physics major and the opportunity to become a Naval Aviator was very intriguing.

After a couple of days of extensive physical and aptitude testing at NAS Floyd Bennett, I was accepted into the Navy's Aviation Officer Candidate program. That summer, following graduation from Colgate, I was on my way to Pensacola for Officer Candidate School and Navy flight training. My career in physics was on permanent hold, as was my gig as lead guitarist for the "Rhythm Demons" planned for that summer at a Lake George resort.

Upon completing OCS and receiving my commission as Ensign in October of 1960, it was on to flight training where I received my Navy Wings in November of 1961. While on active duty, I flew the F8 Crusader, a single engine, single seat fighter, capable of speeds over Mach 2 and 1,000 mph.

In 1962 I served on Naval Intelligence staff at Key West during the Cuban Missile Crisis. I was involved in the hotline to President Kennedy at the White House in October of that year, as a fellow Navy pilot flew an F8 Photo Crusader at tree top level over Cuba and obtained the Russian missile site images that many subsequently saw on television.

In 1965, I left active duty as a Lieutenant and moved west

to Palo Alto to attend the Stanford University MBA program. While waiting for classes to begin, I joined a reserve squadron at NAS Alameda and became qualified on the A4, a small, single seat attack bomber, capable of nuclear delivery. Again, aviation lured me away from higher study and I joined TWA in October 1965, co-piloting the new Boeing 727. Once back in New York, I flew A4's in the reserves at NAS Floyd Bennett where it had all begun in 1960. In 1968 I became a Captain and then Check Airman and Flight instructor for TWA on the Boeing 727.

In 1970, I began several years in TWA's Flight Operations Department at corporate headquarters in New York. My duties involved negotiating pilot labor agreements, handling grievances and developing operational procedures. In 1975 I returned to full time flying, international and domestic, logging about 18,000 hours prior to retirement in 2000. I hold airline pilot ratings on B-727, B-707, B-757, B-767, B-747, L-1011, MD-80 and G-IV aircraft.

After returning to full time flying, I had the good fortune to meet and marry my wife Julie. Then, in the late '80's, it appeared Carl Ican was going to dismantle TWA. With my airline career in peril, Julie and I started an advertising business. Our advertising business continues to this day. Unfortunately, TWA does not.

In 2001, I became Chief Pilot of an aircraft management company at BDR in Stratford, CT, flew a Gulfstream G-4 world wide and managed a couple of dozen corporate pilots until retirement in September 2008. Julie and I have two fine children. Activities include skiing and sailing.

MEMBERSHIP POLICY
